




#### **RWBro John Slade**

Degree in Engineering, concentrating in Water Resources. This was followed with a move to Alberta and working in various engineering consulting companies and organizations, such as Stantec Inc., Associated Engineering, Daltam Consulting, the City of Edmonton, the Canadian International Development Agency and NAIT. During the course of this work he travelled to the Caribbean and Swaziland, where he designed rural water systems and taught at the Swaziland College of Technology. In 1990 Chris started work with Strathcona County in their transportation branch and in 1993 graduated from the University of Alberta with a Masters in Civil Engineering, concentrating in Transportation.

While working on a project in Uranium City, Chris met Wendy Yonkers and they were married 5 May 1978. They have two sons, WBro Aaron Batty and Bro Andrew Batty (Junior Warden), both of Saskatchewan Lodge No. 92.

Chris' interest in Freemasonry stems from his father, who was a member of Bostall Health Lodge No. 4492, EC. # Candidate Essays

At the Grand Lodge of Alberta Annual Communication held in Medicine Hat in 2005, a resolution was passed to amend Regulation 1.2 of the Grand Lodge of Alberta Constitution and Regulations by adding a subsection that would read: Candidates for the position of Deputy Grand Master, Senior Grand Warden and Junior Grand Warden shall be required to publish, in a regularly published and distributed Grand Lodge of Alberta communication, when their nominations are published, an unedited article of approximately 1000 words, but not less than 500 words, outlining their vision for Freemasonry in this Grand Jurisdiction. This article shall focus at least, but not exclusively, on (a) the candidate's description of current issues in Alberta Freemasonry, (b) his proposals for dealing with such issues during the ensuing four years should he progress to the office of Grand Master and (c) his ideas for leading the Craft in Alberta in the future. This year's essays are presented here in an **unedited** form

## RWBro Chris Batty

The history of Freemasonry has demonstrated that it is one of the greatest volunteer leadership training organizations that have ever existed. History has recorded many Brethren, from all walks of life, who have been successful in their chosen field of endeavour.

When a member understands that being active within a Lodge can be a great personal benefit to his self-improvement, he usually becomes an avid and enthusiastic participant of the Lodge.

For some members it takes time for them to understand what Freemasonry can do for them. Time sitting in a Lodge listening to the lectures to the new members, time learning various lectures, and time to present the lectures in the most meaningful way they possibly can. Confucius is attributed to writing "I hear and I forget, I see and I remember, I do and I understand". It is this truth that is fundamental to learning and the basis of Freemasonry, as well as the apprenticeship system that is still in use today for training all of the Craft trades.

Today with all our technology, telephones, computers, email, text messaging, we are an instant society, expecting instant gratification. Learning, however, is not and never will be an instant human process. Humans need the right environment and time to learn anything

Brethren, in today's hectic and narcissistic world our Masonic Lodges and the excellent work performed by Freemasons is of paramount importance. The traditions, tenacity and wisdom which our forefathers set down for us, and that we enjoy today, must be vigorously protected and maintained. It, therefore, falls to us to ensure that we continue to leave such a legacy for the Freemasons of the future.

Freemasonry affords us lessons in ethics, morality, and the vital importance of individual freedoms,

A Freemason's Lodge generally consists of active likeminded men, who work well together, in a safe and charitable environment for their self-improvement, and to better acquaint themselves to the duties they should extend to their family and their community.

This self-improvement is manifested by the member becoming actively involved in the regular running and operation of the Lodge.

The positions in a Lodge facilitate an individual's personal development in personal communications, public speaking, the formalities of organizing, holding, and running both, informal and formal meetings, bookkeeping, understanding and developing financial statements, etc. By sequentially holding each position in a Lodge and fulfilling all of its requirements, an individual member becomes more proficient at personal communications, public speaking, and thereby becomes more comfortable and confident at work and in society in general.

The formal degrees, not only point out the duties we owe ourselves, our families, and our communities, they allow individual members to practice their oratory, verbal, and auditory skills in a quiet, safe and secure environment. While business meetings allow the individual to become better skilled at

choice and responsibility. To some a Masonic Lodge is a social club, to others it is a temple and to others it is a place of solitude, peace and harmony. We have sought the opportunity to become a Freemason, and have chosen to follow a path in our lives of the highest Masonic standards and behaviour. Providing we have the right moral attitude and ethical spirit we can be a valuable and active supporter of our craft no matter what our age or background. Masonry, if we allow it, will guide us in choosing wisely and carefully, once selected, we should follow the designated path faithfully.

responding to questions, or presenting opinions without the aid of formal notes. Further, the presentation of research papers allows the member to become more polished in public speaking.

It is the full understanding of charity or men being charitable to others in society that societies develop and grow. We all prosper in a peaceful and civil society. or a peaceful and civil society to exist, we must be generous, giving, helpful, considerate, understanding, accepting, sympathetic, tolerant, gracious, and lenient. For without these there can be no happy families, no harmonious strong communities, no integrity in business, no successful trade or commerce, and no prosperity, profit, or pleasure.

No other fraternal institution can claim such historic roots as Freemasonry. Because of the philosophy of Freemasonry, it will continue to exist through the ages. For it to thrive and flourish, we the members, must be in tune with the attributes of meeting in a Lodge, ensuring that each member is happy to attend, enjoys the presence of the other members, is encouraged to develop to their full potential, and feels good that he attended the meeting when going home after the meeting.

Our responsibility is to inform our sons, grandsons, nephews, neighbours and co-workers about what Freemasonry offers, the good works we perform show them that we are proud to be part of this fraternity, and by working within our Masonic family will allow the fraternity to flourish as it has throughout history.

Freemasonry is a moral order created by virtuous men and reminds us of sublime truths along with social pleasures; by continuing to work in harmony we can all be part of the futurology of Freemasonry today, to plan for a better world tomorrow and eventually overcome the narcissism that is rapidly taking over our world.
